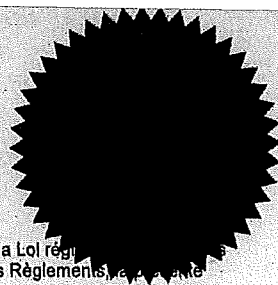

**CONDITIONS RELATED TO CONTROLLED RELEASE FORMULATIONS OF OXYCODONE PRODUCTS:**

1. Sales reports of all controlled release formulations of oxycodone products must be submitted separately to Health Canada within 15 days following the last day of the month being reported on, in a manner and format specified by Health Canada.
2. Reports of theft or unusual loss of controlled release formulations of oxycodone products must be made to the police force of jurisdiction (local police force) within 24 hours after becoming aware of the occurrence. Licensed dealers must confirm to Health Canada within 72 hours after becoming aware of the occurrence that such report has been made and provide a summary of such report, in a manner and format specified by Health Canada.
3. Report of any unusual orders involving controlled release formulations of oxycodone products must be made to Health Canada within 72 hours of becoming aware of such orders, in a manner and format specified by Health Canada.

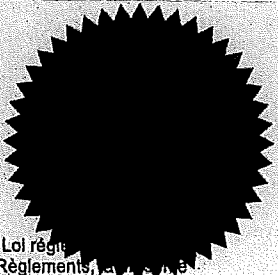

Conditions for Analytical Testing of Cannabis

- 1. As a condition of this licence the analytical testing must be performed on samples of cannabis received from holders of a valid licence issued under the Narcotic Control Regulations, the Industrial Hemp Regulations, the Access to Cannabis for Medical Purposes Regulations or from an individual who is authorized by a valid exemption pursuant to section 56 of the Controlled Drugs and Substances Act to provide, deliver, transport or send fresh or dried marijuana or cannabis oil to licensed dealers for the purposes of analytical testing.
2. The production activity for cannabis is limited to only obtaining extracts from the samples of cannabis received, which is a necessary step for the analysis of cannabinoids.
3. Any remaining material from samples of cannabis received must be destroyed upon authorization by the appropriate Health Canada Regional Office.
4. The analytical testing of industrial hemp must be conducted in accordance to the methodology listed within the Industrial Hemp Technical Manual.
