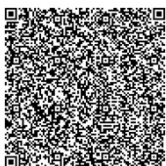

The Animal & Veterinary Service ("AVS") is a cluster of the National Parks Board, a statutory board constituted under the National Parks Board Act (Cap. 198A). The permission is given subject to the following conditions:

1. The permittee shall have in its possession only those pathogens (any living disease germ or virus or any bacterial culture, of a nature harmful or dangerous to animals or birds, or any genetically modified organism, thereafter referred to as "pathogen") approved by AVS and shall keep a record of these pathogens for inspection by AVS.
2. The permittee shall ensure that the storage of or activities involving the pathogens are carried out at an appropriate biosafety level at its facility, and in accordance with its institutional biosafety guidelines. AVS may inspect the facility, when necessary.
3. The permittee shall ensure that any transfer/sale of the pathogens within Singapore is carried out to a person who has been licensed/permitted by AVS to possess the pathogens.
4. The permittee shall not dispose of any pathogens unless they have been adequately treated so as to destroy any infective materials.
5. The permittee shall ensure that no infective materials are intentionally or accidentally carried out of the facility.
6. The permittee shall inform AVS immediately should there be a loss of any pathogens, eg. due to theft.
